3) **Business ownership change question/impact on account numbers** – Deb Belin from Earth Etch

- Deb inquires if when there is a business that changes ownership and wants to keep energy supplier, would the business keep same utility account number. Deb Asks a similar question for residential services, if spouse passes and remaining spouse wants to keep service, would an account number change.
- Josh P. states if there's a name change, change in ownership, or tax ID change, National Grid will require an account change.
- Eric Heaton at ConEd requested clarification on the scenarios.

4) **Utility system updates**

a. Upcoming National Grid billing system conversion – Josh Pasquariello NIMO going through billing system update. 1 billing system update for KEDNY/Mass Gas, it is being folded into the overarching billing system. Scheduled for Memorial Day to completion.

Josh P. states that for KEDNY, they are required to send POR payments the 20th day after meter read. Josh states there is potential for mirroring the process that is followed in KEDLI. If They apply the KEDLI method to the KEDNY system, are there any objections? Josh lets stakeholders know they can reach out to him with their thoughts and is willing to set up a call to discuss the change further.

Deb Belin asks if the change is only for gas. Josh confirms its for gas. Deidre Davis expresses interest in another subgroup call to discuss the matter further.
