Please be advised that this office represents Northeast Energy Development, LLC and we are writing to you on behalf of our client.

This letter is intended to constitute formal **NOTICE** to Millennium of the following:

Please be advised that it is our client's position that as a participating owner in the above referenced well that our client will also be entitled to an ownership and working interest in the gathering line or gathering gas lines for the above referenced well. We believe that the gathering system will include the A-5 Columbia line and related facilities.

As a participating owner, our client will have the opportunity to participate in the cost of the gas gathering system relative to this well. Therefore, it is our client's position that our client must be a party to any agreement, contract or assignment between the operator Anschutz Exploration Corp. and Millennium with respect to the pipeline system related to this well.

Furthermore, we understand that there may be a measurement facility on Hickory Grove Road in Horseheads, New York that will be associated with this well. To the degree that that information is accurate, our client must also be a party to any agreement that will affect our client's ownership interest in the Ruger well.
