NOTICE of Joint Utilities Stakeholder Technical Conference on Electric Vehicle Forecasting Matters

Dear Secretary Phillips:

The Commission, in the Order Establishing Electric Vehicle Infrastructure Make-Ready Program and Other Programs, directed the Joint Utilities¹ to provide "individual EV Charging Infrastructure forecasts in consultation with Staff and to present their forecast methodologies and results during a Technical Conference in calendar year 2021." The Make-Ready Program Order dictated that stakeholders have the opportunity to provide input to inform forecasting processes in the future, including the midpoint review of the Make-Ready Program.

The Make-Ready Program Order also mandated that the Joint Utilities develop the Suitability Criteria including Strategic Locations. The Joint Utilities will solicit feedback from stakeholders on the criteria and definition of Strategic Locations.
