- b. field on 867 – currently optional
-NY Needs to adopt the standards in place by the majority of other utilities in the US. Responses have been positive to move forward with the change request. Kim Wall soliciting comment from participants to make the field required instead of optional.
-Jeff at Noco Energy voiced support for making the field required. It would improve communication for suppliers with utilities.
-Billing issues are the primary reason for the field to be required. If the information in the field is not provided, it can cause issues with billing on the 810s.
-Kim Wall suggests utilities all utilities/participants comment on this. Utilities requested to determine what the cost of this would be and what a timeline for completion would look like.
