Change to ONE BILL report on Energy Markets Web (NiMO). The report has different rates on it, and ESCOs can use it to see what the rates being charges are. There is confusion between what is a fixed rate and what is a fixed rate adder. NIMO inquiring if they add a column, would it be problematic from any ESCO or EDI Provider standpoint.

NIMO asks if the change in question would pose any issue for ESCOs or EDI providers. Josh P states if people need to take the question back, then that is fine, take the questions back and follow up with Josh P.
