
Context Setting: The Utilities welcome feedback from stakeholders

- Today's discussion will focus on stakeholder engagement in the CGPP process: the EPPAC
 - The Utilities' plans for the CGPP remain in development
 - This series of Technical Conferences is an effort to gather stakeholder input and feedback
- Note:
 - The period for submitting comments re: the CGPP is open through December 21, 2022
 - The Utilities plan to submit a revised plan for the CGPP on January 1, 2023



Recap: Objectives of the CGPP

- The goal of the Coordinated Grid Planning Process (CGPP) is to identify expansion of the local transmission and distribution systems that can help unlock renewable capacity and energy for the purpose of meeting New York State clean energy goals (*i.e.*, the CLCPA mandates)
- CGPP will serve as the basis for the statewide integrated resource planning process





Stakeholders will provide insights on modeling approaches in the EPPAC

- The role of the EPPAC is to:
 - Evaluate the modeling assumptions that form the basis of assumptions behind the planning models used to design the system to achieve 70 x 30 and 100 x 40 objectives
 - Direct the evaluation of up to three distinct ٠ **Generation Buildout Scenario 1** Sensitivity 1(a) generation build-out scenarios^{*} Sensitivity 2(a) Inform the need for analysis of sensitivities that **Generation Buildout Scenario 2** ۰ Sensitivity 2(b) may be run on each of the three principal Sensitivity 2(c) scenarios (*i.e.*, to inform other needs) **Generation Buildout Scenario 3** Sensitivity 3(a) Review draft materials that will feed into a report ٠ on the CGPP's conclusions in each successive cycle
- The Utilities propose that DPS Staff, NYSERDA, or a Staff-selected consultant would continue to coordinate and host the EPPAC discussions
 - The EPPAC is intended to be independent and stakeholder-led

*As discussed in the June 15 Capacity Expansion Tech Conference, this is required to maintain the current CGPP cycle of 18-24 months



EPPAC Composition

- In the December 17, 2021 filing the Utilities proposed the creation of the EPPAC as the new, technical advisory council attached to the CGPP process.
- The recommended composition is as follows;




EPPAC Composition (cont.)

- The stakeholder committee is currently providing feedback on the Utilities' plan to develop the CGPP process to be filed by January 1, 2023
- The existing stakeholder committee role and composition will continue/evolve into the EPPAC
 - Once the CGPP is approved by the Commission the Utilities envision that the stakeholder committee/EPPAC will focus on technical approach to the CGPP's analysis
- The Utilities are proposing that DPS staff coordinate the process for the addition and removal of EPPAC members
