Thank you for reaching out to the Town of Nelson as EDRs representative for the proposed project on behalf of your client Liberty Renewables, Inc.

Route 20 intersects east to west in the middle of the Town of Nelson. Route 20 is a scenic byway as established within our masterplan and our LUR. that protects the existing scenic viewsapes. Loss of this essential viewscape will have a negative impact on the Towns economic viability. Have you evaluated the viewscape economic loss to our Town? Please send me your evaluation of the economic loss to our Town as soon as possible.

How do you plan to address the visual viewscap issues as your project will definitely impact our designated RT 20 scenic byway?

The Town of Nelson established a wind energy moratorium. How will you address our moratorium?

The existing electrical transmission lines are not sufficiently sized to convey the energy being produced by your project. I understand that electrical storage will be part of your project. Is this true? What is the proposed location of the storage facility? How will your proposed storage area impact the Route 20 scenic byway within our Towns?

What is the proposed max height of the windmills your client is proposing? Have you developed a viewscape impact document and drawings for our Town to review? Will you please send that document and drawing(s) to me at your earliest convenience?

Can you please send me a copy of your agreement with Liberty Renewables, Inc. and a copy of your professional liability insurance policy covering this project.

Dear Kiva,

Thank you for sending ORES the VIA Information Request for the Hoffman Falls Wind Project. Based on our review of the material dated 10/5/2023, we offer the following comments and/or requests for the Application submission.

To help the Office assess a selection of important or representative viewpoints, please provide updated GIS shapefiles and a KMZ google earth file to correspond with Figure 2 Potential Visibility and Viewpoint Locations for the wind turbines. Please include the proposed turbine locations, proposed location of the O&M building/point of interconnection, turbine visibility, 5 mile study area boundary, viewpoint (VP) locations, and all visual resources labeled as identified on Table 1 Inventory of Aesthetic Resources.

An analysis of cumulative impacts should include the cumulative visual impacts of the various structures proposed for the wind energy facility and an analysis of the cumulative visual impacts of the project together with existing wind facilities and the proposed Oxbow Hill Solar project. (see <https://ccrenew.com/projects/oxbow/>)

Please update the Attachments with the following information:

1. General/Attachment A Figures
  - a. Provide an ID label for each turbine location on 1:24000 mapping.
  - b. Include the alignments of any proposed overhead transmission lines and the location/fencing line for the point of interconnection (POI) and substation facilities on all 1:24000 mapping.
  
2. Attachment C - Visually Sensitive Resources
  - a. Line-of-sight (LOS) analysis should be completed for VSR's to confirm partial visibility as listed in Attachment C: Visually Sensitive Resources, including additional VSR's as suggested below.
  - b. Provide a column identifying visibility based on LOS analysis on Attachment C
  - c. National Register Eligible (NRE) properties should be included in addition to NRL properties as they are given the same amount of protection under state and federal law. A list of eligible resources is available from SHPO's database – there are a number of eligible individual resources and historic districts in the study area. Newly identified NRE properties can be added to the listing after the Historic Resources Survey occurs.
  - d. Under Figure 2, Sheet 4: please change the label from “National Historic Site” to “State Historic Site.” This is a combined category on Attachment C but the only relevant resource is a State Historic Site.

- e. Include cemeteries as local resources.
- f. Oneida Indian Nation (OIN) lands should be included as VSR's. There is a Smithfield parcel that is in close proximity to the turbines. We also note that the entirety of the Towns of Fenner and Smithfield are within the boundary of the Oneida Reservation.

3. Attachment D - Viewpoint Photo Selection and orientation:

- a. Additional photos should be provided along Route 20/Main Street in the Village of Morrisville and at high points approaching the Village from the east and west along Route 20
- b. VP 25 Additional photo oriented North-northwest to North
- c. VP 26 Additional photo oriented North to North-northeast
- d. VP 41 Additional photo oriented North-northwest to Northwest
- e. VP 42 Additional photo looking Northwest
- f. Additional photos of proposed POI and substation facilities

4. Photo-simulations

- a. Note that leaf-on photos are required and at a minimum 2 year growth are required for visual simulations and that leaf-on photos are required for any photo-simulations where existing vegetation is relied on for screening
- b. Additional photo-simulations should be prepared for views along Route 20, at a minimum to include east and west Village approaches to Cazenovia and Morrisville, and Village of Morrisville near the old County Courthouse
- c. VP 25 photo-simulation should be oriented North-northwest to North
- d. VP 26 photo-simulation should be oriented North to North-northeast
- e. VP 41 provide photo-simulation, should also be prepared looking North-northwest to Northwest
- f. VP 42 Provide photo-simulation, should also be prepared looking Northwest
- g. VP 50 Provide photo-simulation
- h. VP 58 Provide photo-simulation
- i. VP 63 photo-simulation should be oriented towards the proposed wind farm
