CASE 25-T-0184 - Petition of Niagara Mohawk Power Corporation d/b/a National Grid for Certificate of Environmental Compatibility and Public Need, Pursuant to Article VII of the Public Service Law, for the Reconstruction of Approximately 60.9 miles of 115kV Transmission Line Running from the Black River Substation in the Town of LeRay, Jefferson County, to the Clay Substation, in the Town of Clay, Onondaga County, and the Construction of a the New Staplin Creek Substation in the Town of Rutland, Jefferson County.

# NOTICE REQUESTING COMMENTS AND ANNOUNCING VIRTUAL PUBLIC STATEMENT HEARING

(Issued December 4, 2025)

On March 14, 2025, Niagara Mohawk Power Corporation d/b/a National Grid (National Grid) filed an application pursuant to Public Service Law Article VII for a Certificate of Environmental Compatibility and Public Need (Certificate). If granted, the Certificate would authorize National Grid to rebuild several portions of its existing 115 kilovolt (kV) transmission lines running from the Black River Substation in the Town of LeRay, Jefferson County, to the Clay Substation in the Town of Clay, Onondaga County, a distance of approximately 60.9 miles (the Project). The Project traverses the Towns of LeRay, Rutland, Rodman, Worth, and Lorraine in Jefferson County; the Towns of Boylston, Orwell, Albion, Parish, and Hastings, and the Village of Central Square in Oswego County; and the Towns of Cicero and Clay in Onondaga County.

The Project is essentially broken down into two sections: (1) the 35.9-mile-long double circuit Black River to Light House Hill section and (2) the bussed Light House Hill to

Clay section which is 25 miles long. Both sections will be rebuilt as single circuit facilities. The Project also includes expanding the existing Staplin Creek Substation beyond the current fence line and National Grid's property. Full Project location details are in Exhibit 2 of the application.

Under New York State Law, the Public Service

Commission (Commission) may adopt or reject National Grid's

proposal, in whole or in part, or modify it. In doing so, the

Commission will consider input from those participating in this

proceeding and the public.

Any person wishing to provide a public statement on the record during the virtual public statement hearing must register to do so by 4:30 p.m. on Monday, January 12, 2026, in accordance with the instructions set forth below.

### To register and provide a statement electronically:

### To listen to the hearing without making a statement:

All participants will be muted upon entry into the hearing. Each person who registered to speak will be called upon to make a statement. The ALJ will continue the hearing until everyone wishing to speak has been heard or other reasonable arrangements to submit comments have been made. Reasonable time limits may be set for each speaker as necessary to afford the speakers an opportunity to be heard. It is requested that lengthy comments be submitted in writing and

summarized for oral presentation. A verbatim transcript of the hearing will be made and posted to the Department of Public Service's (Department) website.
