Hi Supervisor Wicks,

I hope you are doing well – it'll be spring before we know it! I am following up on behalf of Liberty Renewables to request your availability to meet with members of our team in late March, specifically sometime during the week of 3/25 to 3/29. Now that Liberty has filed a 94-c permit application for the Hoffman Falls Wind Project with the Office of Renewable Energy Siting, we are hoping to pick up on a discussion we started with you in November/December about developing a Road Use Agreement (RUA) with the Town of Eaton.

Specifically, we would like to sit down with you and your Highway Superintendent (as well as any other select Eaton Town representatives that you'd like present, perhaps the Planning Board Chair, Town Engineer, etc.) to have a detailed discussion about the provisions included in the draft RUA that we shared, and to get your input on local considerations, including town road, culvert, or bridge conditions that you feel have the potential to pose an issue from a transportation standpoint for the project. **Subject:** Hoffman Falls Wind Project Road Use Agreement Meeting Request - Madison County

To Madison County Highway Superintendent Joe Wisinski and Attorney Tina Wayland-Smith:

I hope this email finds you well. My name is Juliana, and I am a Permitting Associate with Liberty Renewables. As you may know, Liberty is developing the Hoffman Falls Wind Project, a proposed up to 100-megawatt (MW) wind energy generating facility including up to 24 turbine locations and associated infrastructure within the Towns of Fenner, Nelson, Eaton, and Smithfield in Madison County, NY. As of February 2024, our team filed a 94-c permit application for this project with the New York State Office of Renewable Energy Siting (ORES). I am emailing today with the hope to engage your expertise and initiate a conversation about developing a Road Use Agreement (RUA) with Madison County for Hoffman Falls Wind.

For your awareness, the Liberty team is working to pick back up on discussions with the Fenner, Nelson, Eaton, and Smithfield Town Supervisors and Town Highway Superintendents about the RUA process. We began preliminary consultations on this topic with each town in late 2023, providing a draft agreement to base the conversation and requesting their input on local considerations, including town road, culvert, or bridge conditions that could pose an issue from a transportation standpoint for the project. While we will continue these consultation efforts in the coming months, we are very interested in engaging at the Madison County level, and specifically with your Highway Committee and Counsel, to share information about the project and obtain feedback pertaining to a potential RUA for the project.

We would love to set up a meeting, perhaps late this month or mid-May, to introduce the Liberty team and kick off a preliminary discussion around this effort.

This discussion would reference the Traffic Control Delivery Flow Plan that was included in our 94-c application, now available within the Hoffman Falls Wind Document Matter Master at this link:

As you will see in the linked figure, we anticipate utilizing specific sections of both Madison County and Town roads for turbines component delivery at construction. The following are the County roads that are called out as part of this plan: CR 28, CR 25, and CR 45. Please note that this delivery route is preliminary and could change in some respect as we get closer to construction depending on the turbine model that is ultimately selected for the project and where in the country that model is being delivered from. The construction period for Hoffman Falls is anticipated to begin in 2026 and continue for 12-18 months. Ahead of our meeting, the Liberty team can also provide a draft RUA document for the County's review, unless your Highway Committee already has a working reference that you'd prefer we start with.

**Please let us know your availability during the week of April 22 to 25 and/or the week of May 13 to 17.** We'd be happy to meet at the Madison County offices if that works well for you.
