The cemetery is organized around a central path, with grave markers in north-south rows. Grave markers represent common period types, including slate tablets (early

Physical Description: nineteenth century), marble tablets and obelisks (mid- to late nineteenth century), family monuments with individual headstones (late nineteenth to early twentieth century), and individual or paired granite markers (twentieth century). Significance:** Stewarts Corners Cemetery was established as early as 1784 and served as a community burying ground for the hamlet of Stewarts Corners. The cemetery appears to meet National Register Criterion A in the area of Exploration/Settlement for its association with the early history of the Town of Venice, as well as Criterion C in the area of Art for its collection of period funerary monuments.

Physical Description: The Sager House is a two-and-one-half-story Queen Anne-style residence built on a cross-gable plan in the Village of Moravia. It has a parged foundation, wood clapboard and wood shingle siding, and an asphalt shingle roof. The primary entrance is in the west bay of the three-bay façade and sheltered by a front-gabled portico with a scroll saw cut-out piece in the

This portico is part of a full-width porch, which spans the façade, has a shed roof, and features spun wood supports, balusters, and railings, and a spindlework frieze. Fenestration along the residence is characterized by one-over-one windows with wood trim headers and shutters. There is a wide band of wood shingles between the first and second stories that has decorative trim along its top and bottom. The gable ends feature diagonal board cladding, decorative trim, and bracketed scroll saw cut-out detailing at the top. The property also has a two-story front-gabled carriage barn with a garage door, board-and-batten siding, and a sheet metal roof.

This single door is set within a modest trim surround and sheltered by a porch with decorative spindlework and a roof that flares from the addition's double-hipped roof. A matching porch along the main volume's east elevation, with a shed-style roof instead, shelters a window that appears to have once been an entrance. The north elevation of the main volume has chamfered corners at the first story that are occupied by windows and have spindlework at the top. Fenestration throughout the residence is characterized by one-over-one windows with modest wood trim surrounds, though the second story of the main volume's north elevation has a set of paired windows with wood trim panels between them. In addition, the top of each gable end has a square awning window with wood trim surround and an entablature. A band of decorative trim surrounds the top of the first story, and another trim profile surrounds the top of the second story, beneath the wood shingle-clad gable ends.

Statement of Significance: The A.B. Hale House is a Queen Anne-style residence located near one of the major intersections of the Village of Moravia. Historic maps suggest that Austin Benham Hale (1817-1897) owned a residence on this lot from at least 1853, and his estate still owned it in 1904, though the residence's style suggests that it replaced an earlier residence in the late nineteenth century. The residence retains its integrity of location, setting, design, materials, and feeling. Thus, it appears to meet National Register Criterion C in the area of Architecture as an extant example of a Queen Anne-style residence in the Village of Moravia.

Physical Description: The Howell Farmstead is a 144-acre agricultural property that features a modestly ornamented Italianate-style farmhouse, a large barn complex, a single-story barn with a saltbox roof, and a front-gabled crib barn. The two-story farmhouse has a central double-hipped-roofed block with a gable-front wing running north along the west, another gable-front wing

Physical Description: running east along the south, and a gable-front wing running south from the rear of that wing. The primary entrance occupies the eastern two bays of the central block and is flanked on either side by a window and sheltered by a porch, which has a hipped roof supported by decorative square columns and brackets. There is a secondary entrance on the east elevation of the western wing, within the front porch, and another on the north elevation of the southern wing, beneath a bracketed portico with a hipped roof. The fenestration is characterized by two-over-two single-hung windows with wood trim surrounds. The large barn complex is essentially L-shaped and comprises two perpendicular gambrel-roofed barns with a series of additions that have either a shed or front-gable roof. The other two barns are oriented north-south and near one another to the southwest of the farmhouse. Most of the barns and their additions have wood vertical board siding, though concrete block and wood clapboard are also present in the barn complex, and all barns and additions have corrugated sheet metal roofs.

Statement of The Howell Farmstead is a 144-acre property that is still in agricultural use.

Significance: According to historic maps of the Town of Locke, the farmstead remained within the Howell family from at least 1853 to at least 1875. It retains integrity of location, setting, design, materials, and feeling. Thus, the farmstead appears to meet National Register Criterion A in the area of Agriculture for its association with the development of Locke's agricultural economy, as well as Criterion C in the area of Architecture as an example of a farmstead with a vernacular Italianate-style farmhouse and an assortment of mid-nineteenth- to early-twentieth-century agricultural buildings.

Statement of The cottage at 420 Woodside Way appears to have been constructed prior
Significance: to 1875, when it was identified on the F.W. Beers County Atlas of Cayuga, New York as a tenant house on the lakefront property of William Henry Seward, Jr. (1839-1920). Seward - youngest son of noted Secretary of State, Governor of New York, Senator, and abolitionist William H. Seward - was a banker and a Civil War Brigadier General. Following his military service, he returned to reside in the family's home in Auburn. By 1875, he had acquired the lakefront property that would afterwards be known as Seward Point. The lakefront summer estate was known by the family as "Woodside." The cottage at 420 Woodside Way appears to be a ca.-1875 residence remodeled in the Queen Anne style in the late nineteenth or early twentieth century. The Seward family's primary residence on the site appears to have been the extant cottage at 408 Woodside Way, a two-story residence which has been substantially altered and does not appear to meet National Register criteria due to the loss of integrity of materials and design. Many nineteenth- and early-twentieth-century cottages on Owasco Lake have been substantially altered through enclosure of porches and replacement of siding and windows. The cottage at 420 Woodside Way appears to retain sufficient integrity of location, setting, materials, design, feeling, and association to convey its significance under National Register Criterion C in the area of Architecture as a representative example of a nineteenth-century lakefront cottage.

Statement of Significance: The cottage at 428 Woodside Way appears to have been built in the late nineteenth century and possibly expanded through the addition of a rear volume connected via a tall, hipped roof. Located on Seward Point, the cottage may have been part of "Woodside", the lakefront summer estate of the William Henry Seward, Jr. family. The tripartite facade arrangement, with a wraparound first-story porch and a second-story gabled sleeping porch, is common among surviving late-nineteenth-century lakefront cottages on Owasco Lake. Many nineteenth- and early-twentieth-century cottages on the lake have been substantially altered through enclosure of porches and replacement of siding and windows. The cottage at 428 Woodside Way is one of the few nineteenth- or early-twentieth-century lakefront cottages on Owasco Lake which retains sufficient integrity of materials and design to convey its significance under National Register Criterion C in the area of Architecture, as an example of a late-nineteenth- or early-twentieth-century Queen Anne-style cottage on Owasco Lake.

Statement of Significance: A farmstead was established on the site of the Ames Farmhouse prior to 1853. The current dwelling was constructed ca. 1860, likely replacing an earlier dwelling, for Chester C. Ames (1801-1880) and Elmina Janet Hotchkiss Ames (1819-1877). In 1850, it was a 120-acre farm producing cereal crops, butter, wool, maple sugar, and orchard fruit. The farm was inherited by the Ames' son Herman Ames (1847-1894) and remained in the Ames family at least into the early twentieth century. Despite the loss of a period barn complex and diminishment of the farm's historic acreage, the house retains its rural, agrarian location and setting. It also retains integrity of design, materials, workmanship, and feeling. Supported on fluted Ionic columns and engaged pilasters, the pediment contains a large fanlight. The primary entrance consists of a non-original glazed wood door flanked by sidelights delineated by pilasters and surmounted by a transom featuring wrought iron detail and a carved wood lintel matching those of the windows. The porch railing and stairs are non-historic. Corner pilasters echo those at the entry porch, and a second fanlight is located in the gable end of the south elevation. The north elevation has a pair of smaller wood windows at the gable end.

Statement of Significance: The John E. Beardsley House was constructed in the mid-nineteenth century and was the home of merchant John E. Beardsley (1811-1865), son of New York state politician and banker John Beardsley. The residence is an excellent and highly intact example of modestly scaled, high-style Greek Revival domestic architecture retaining almost all of its original exterior fabric. It retains integrity of location, setting, design, materials, workmanship, feeling, and association, and appears to meet National Register Criterion C in the area of Architecture as a notable example of Greek Revival domestic architecture in the Town of Scipio.

Statement of Significance: The I. Akin Farmstead was established in the early nineteenth century, possibly by Isaac Akin (1798-1877) and Phebe Tompkins Akin (1803-1878). By the late 1850s, the farmstead was the home of their son Ira Akin (1823-1862). Isaac Akin served for 25 years as a Deacon of the Scipio Baptist Church (located directly east of the farmstead across NY-34), and is commemorated with a memorial window in the church. Although the farmstead as a whole does not appear to have sufficient integrity of design to meet National Register Criterion A in the area of Agriculture (due to loss and alteration of its agricultural buildings), the brick residence appears to meet Criterion C in the area of Architecture as a notable example of Greek Revival-style domestic architecture in the Town of Scipio.

Cayuga Lodge 221 was founded in 1851 and began using the former church building after 1904. As of 2024, it is still an active Masonic lodge. Despite the loss of the tower, the addition of the glazed awning (which is reversible) and limited use of vinyl siding, the building appears to retain sufficient integrity of location, setting, design, materials, feeling, and association to meet National Register Criterion A in the area of Architecture as an example of Greek Revival-style ecclesiastical architecture in the Town of Scipio.
