Figure 3-5. Parcels within 2,000 feet of the Facility - Revision 1

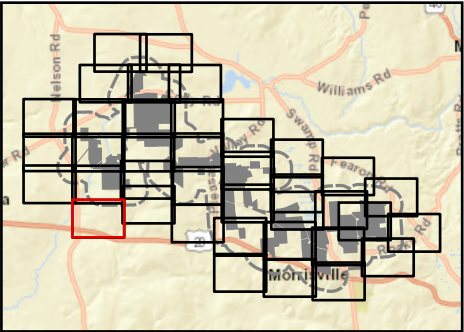

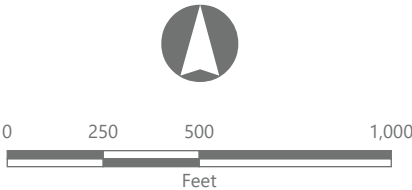

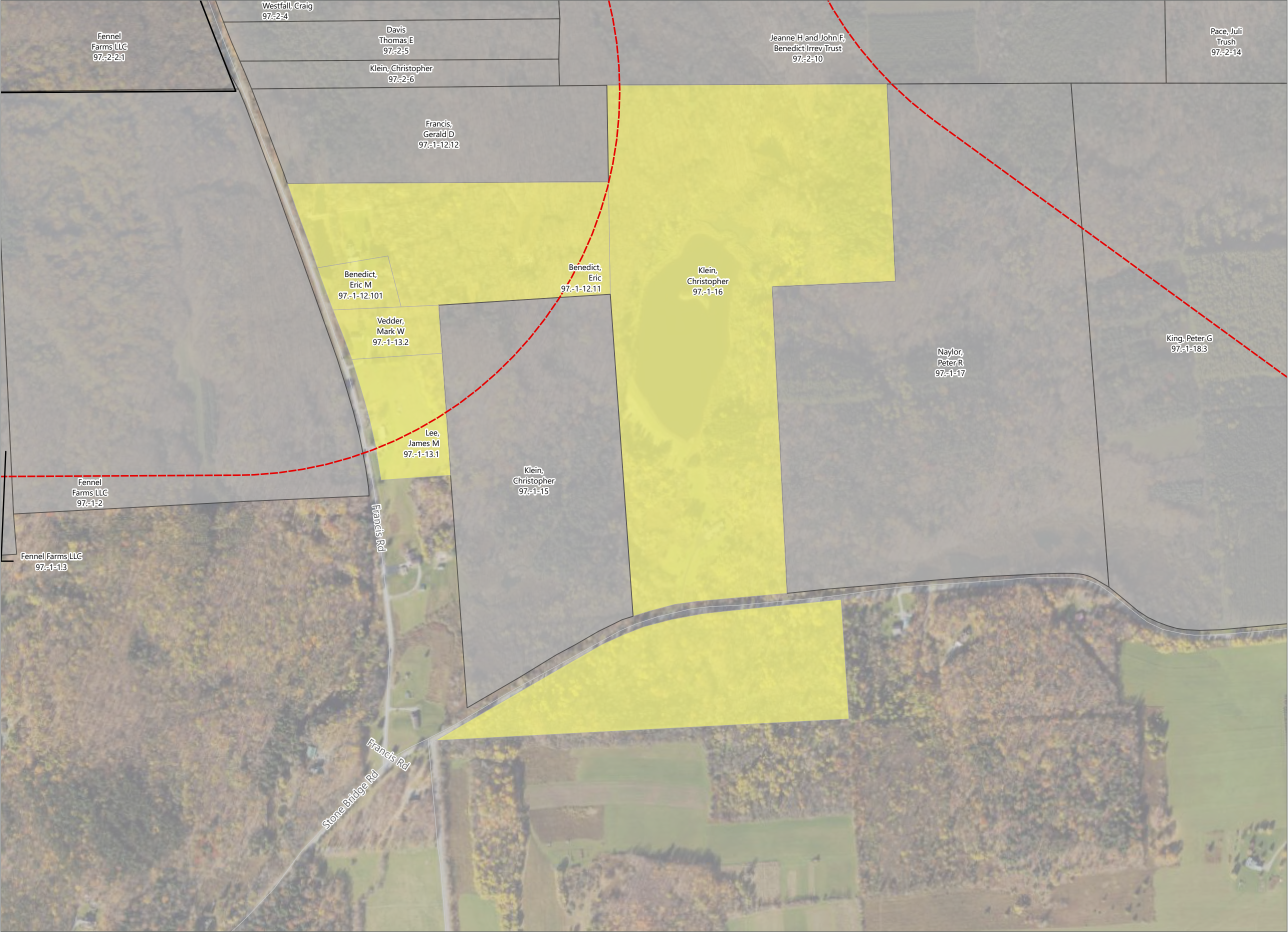

Figure 3-5. Parcels within 2,000 feet of the Facility - Revision 1

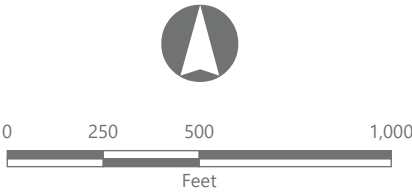
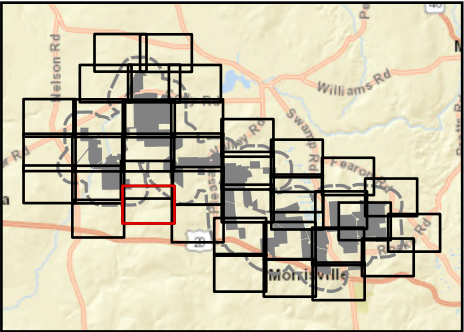

Figure 3-5. Parcels within 2,000 feet of the Facility - Revision 1

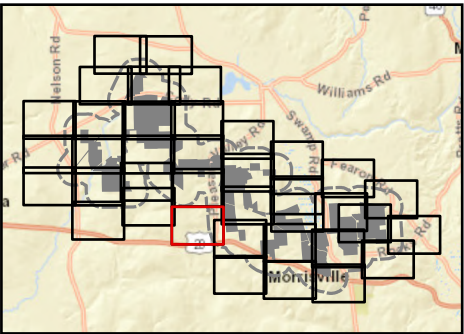

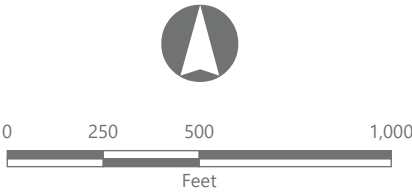

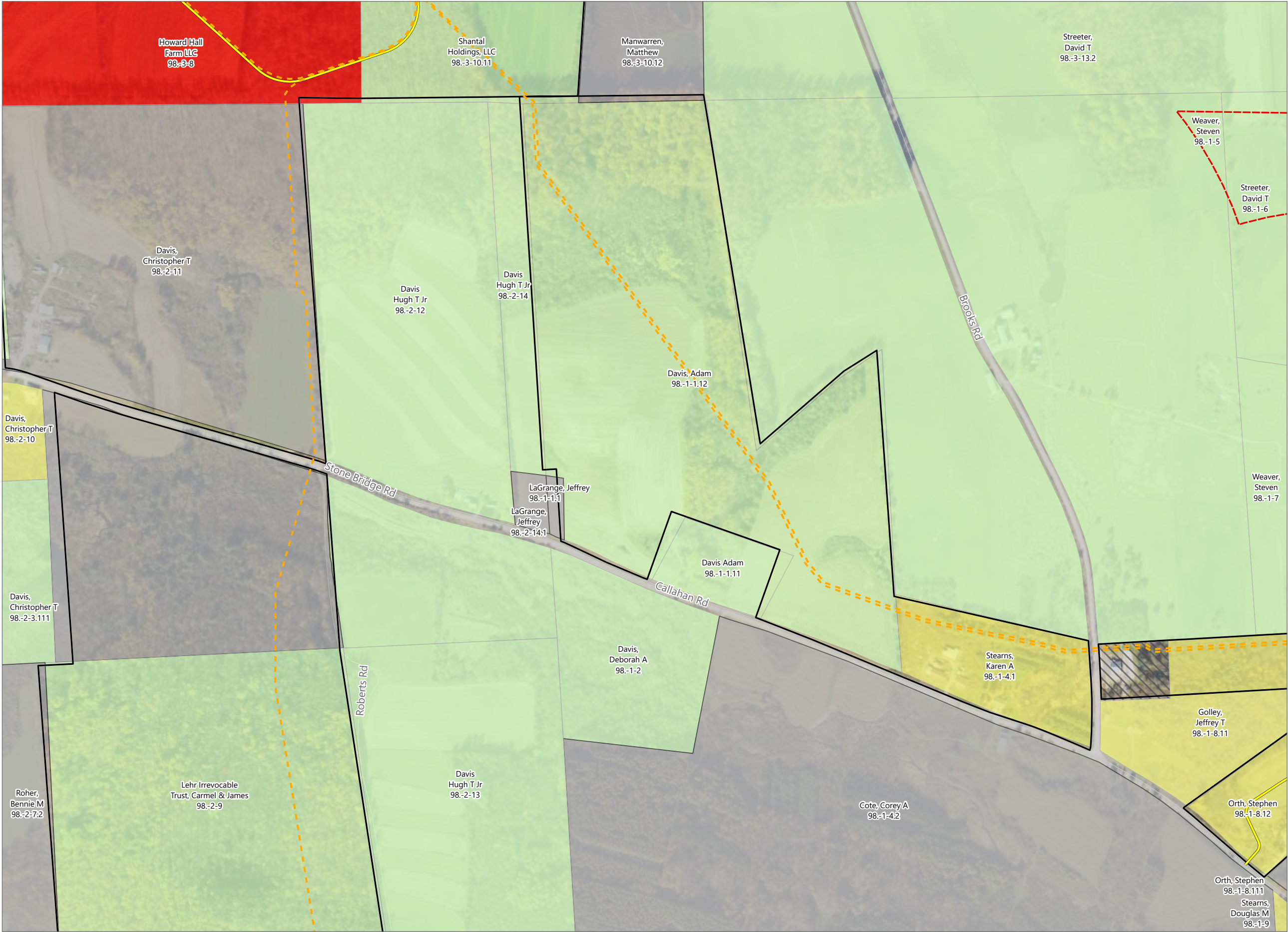

Figure 3-5. Parcels within 2,000 feet of the Facility - Revision 1

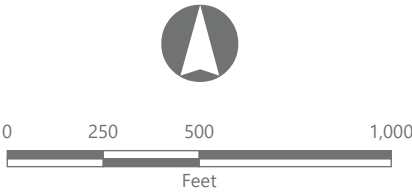
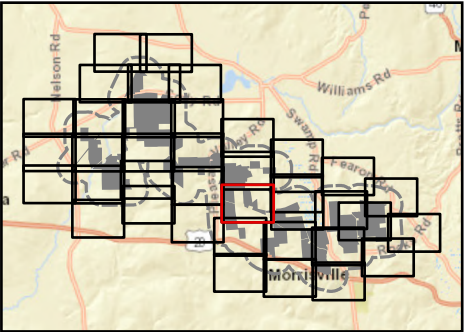
