

Public Notifications



 NRC uses a different protocol for issues that have an immediate risk to the public

 If there was an Emergency, the Emergency Plan would be activated. This is rare and even more so for a decommissioning plant.

ISFSI Inspections at Indian Point

- At least 14 inspections since 2008 when the site began loading ISFSIs
- Inspectors trained on ISFSIs and formal program established in 2012
- NRC Inspection Reports are available to the public in ADAMS

- Issues identified assessed Enforcement Policy
- Inspections are intrusive, sometimes more than one inspector
- Inspection Results publicly available
- Violations are processed through our Enforcement Policy
- Notifications to Public have different protocol
