**PLEASE TAKE NOTICE** that staff from the New York State Energy Research and Development Authority (NYSERDA) and the Department of Public Service (DPS) will convene two webinars to discuss "New York's 6 GW Energy Storage Roadmap, Policy Options for Continued Growth in Energy Storage" (Storage Roadmap). The Storage Roadmap was filed on December 28, 2022.

2. Responses to questions received prior to the webinars.
3. Live Q&A.
