## **AGREEMENT**

This Agreement made and entered into on the date when signed by the party signing last in time, by and between The Brooklyn Union Gas Company d/b/a National Grid (hereinafter the “Company”), a New York corporation with offices at One Metrotech Center, Brooklyn, NY 11201 and The Hallen Construction Co., Inc. (hereinafter the “Contractor”), a New York corporation, having its principal place of business at 11 Commercial Street, Plainview, NY 11803 for the Work identified as:

ARTICLE 2 – NON-DISCLOSURE/CONFIDENTIALITY

Notwithstanding any other provision of this Agreement, the Parties recognize that they will share certain confidential, proprietary, and nonpublic information (“confidential information”) with each other in connection with this Agreement. Accordingly, all such confidential information exchanged by the parties in connection with this Agreement is governed by the Non-Disclosure Agreement dated (1/21/2022) attach to this Agreement as Exhibit A (“NDA”). The NDA shall continue to govern the Agreement notwithstanding any expiration or termination of such NDA.

ARTICLE 3 - SCOPE OF WORK

The Contractor hereby agrees to provide all materials, equipment, apparatus, tools, qualified labor, qualified supervision, services, insurance and facilities necessary to perform all Work in accordance with all the specifications and contract documents associated with this Agreement.

ARTICLE 4 - SCHEDULE

Any work to be performed under this Agreement shall be commenced and completed in accordance with the work schedules delineated in Exhibit H: Schedule, 2/8/2022.

ARTICLE 5 – AGREEMENT DURATION

This Agreement, unless lawfully terminated earlier, shall continue in force to the extent the Contractor continues to provide services under the relevant scope of services. The Company reserves the right, at its sole option, to cancel this contract at any time and for any reason.

ARTICLE 6 - CONTRACT PRICE

The contract price for the Work shall be in accordance with Exhibit F: Pricing Workbook, dated 2/10/2022, below, and shall be equitably adjusted to cover any additions, deletions or changes to the Project pursuant to Section 6.0 of the Terms and Conditions and for any adjustments required under Section 35.0 of the Terms and Conditions.

ARTICLE 7 - NOTICES
