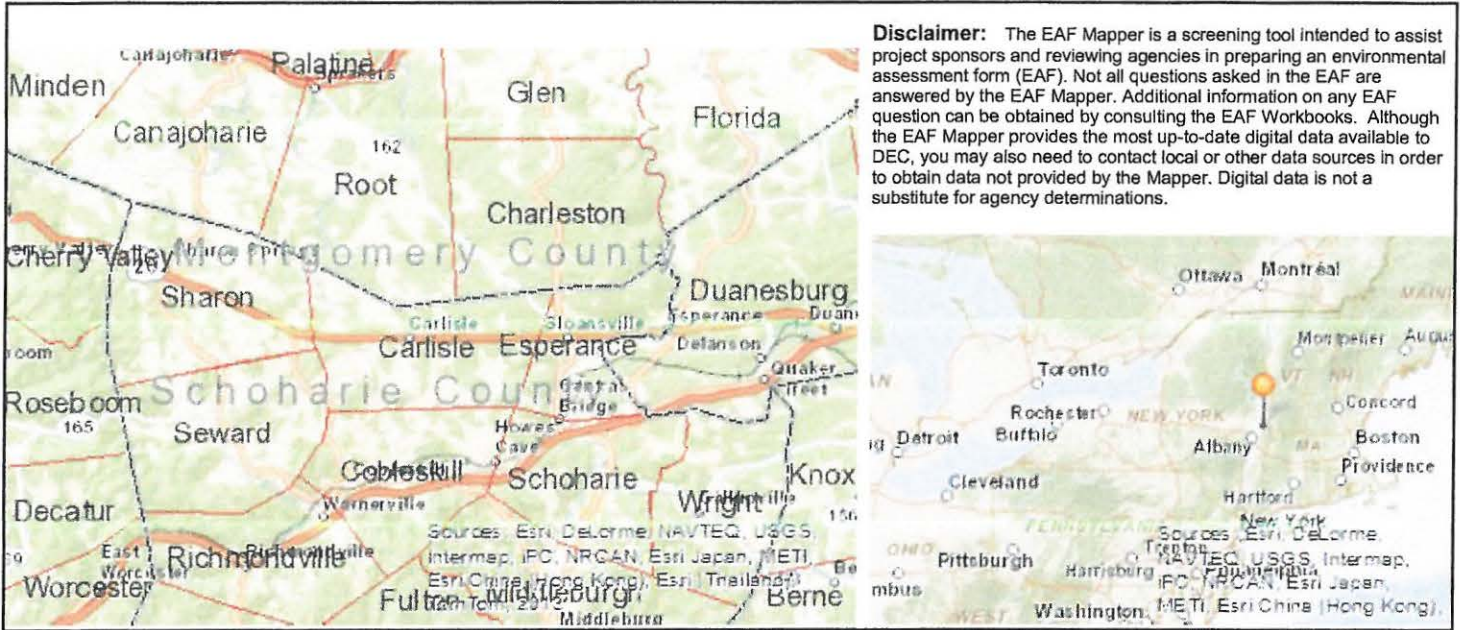

3. PROJECT DESCRIPTION

- a. Pursuant to a Franchise Agreement with the Town of Carlisle, New York, Time Warner proposes to run a cable and internet system utilizing overhead lines with pole attachments located within the right of ways of the Town of Carlisle passed the addresses contained in Exhibit # 3.
- b. A map of the proposed project area is contained in Exhibit # 4.

- c. No poles, equipment, or wires will be located on any active agricultural or environmentally sensitive lands.
 - d. Time Warner customers will receive cable television, internet, and digital phone service through coax service wire from over head poles to the customers' homes and/or buildings.

Map of Project Area



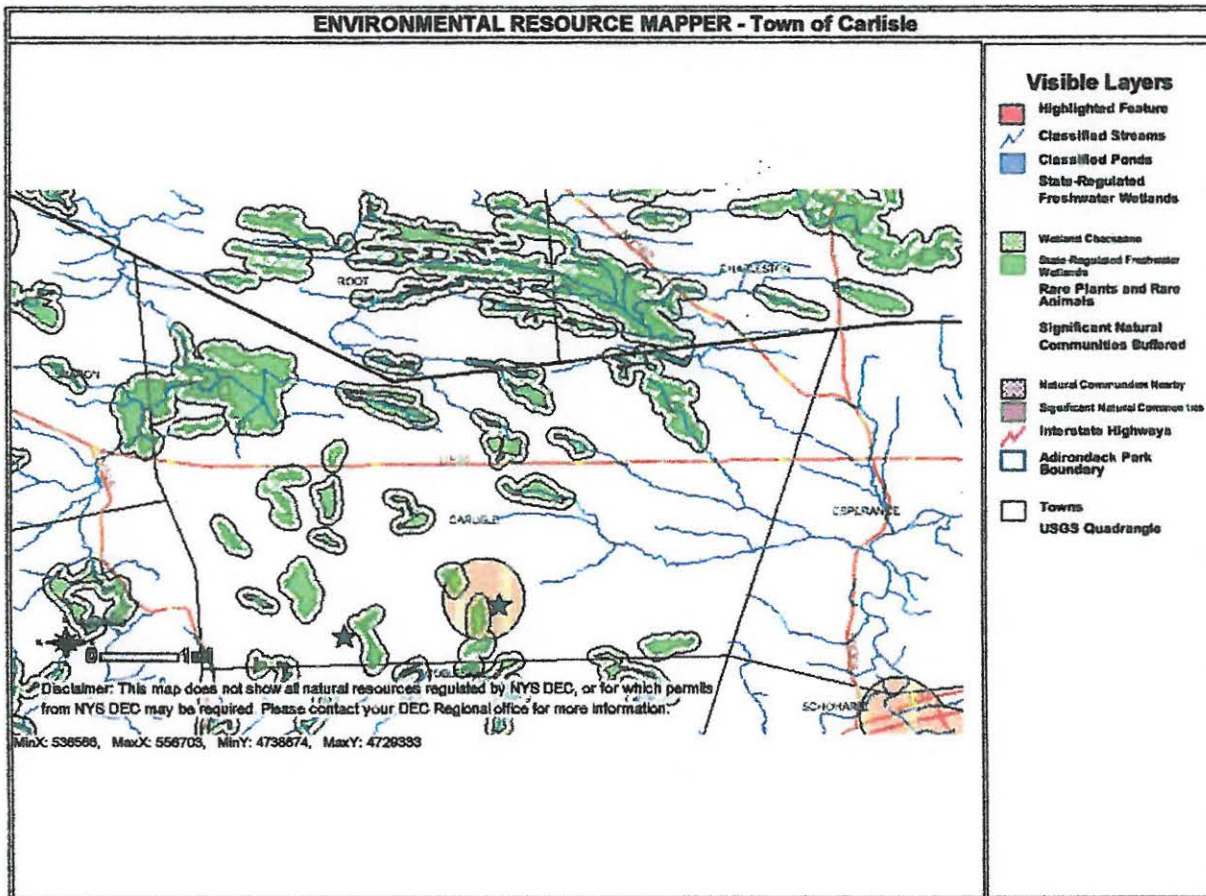
