Dear Speaker Heastie:

This is to inform you that Bluestone Wind, LLC has submitted a Preliminary Scoping Statement to the New York State Board on Electric Generation Siting and the Environment (Siting Board) regarding its proposal to develop its 125 MW Wind Energy Project in the Towns of Windsor and Sanford, in Broome County. The filing triggers the need to appoint ad hoc public members to the Siting Board to participate in the review of the proposed facility.

Pursuant to Article 10 of the Public Service Law, in your capacity as Speaker of the Assembly, you should be receiving nominations of four candidates each for ad hoc public members from the Towns of Windsor and Sanford, and Broome County. You have 30 days from receipt of the list of nominated candidates to appoint one ad hoc member from the list of candidates. If you do not make an appointment within 30 days, the Governor shall appoint the ad hoc member from the list of nominated candidates. If an ad hoc member has not been appointed within 45 days, a majority of persons named to the Siting Board shall constitute a quorum.
