Dear Secretary Brilling:

Pursuant to the New York State Public Service Commission's ("PSC" or "Commission") Order Establishing Rate Plan, issued and effective September 21, 2010 (the "JP Order"), in Case Nos. 09-E-0716 and 09-G-0717, Rochester Gas and Electric Corporation ("RG&E" or the "Company") respectfully submits its Annual Report of its Electric and Gas Economic Development Plan for 2011 (the "Report"). As approved by the JP Order, this report of annual incentives is submitted in accordance with Section XI.N of the Joint Proposal, which incorporates prior Commission Orders that address economic development, except as modified by the Joint Proposal.

The JP Order approved changes to economic development funding to reduce the annual funding included in the delivery revenue requirement to \$4.985 million per year for electric and gas.

Electric Rate Incentives: \$1.163 million
Electric Non-Rate Assistance: \$3.6 million
Gas Rate Incentives: \$122,000
Gas Non-Rate Assistance: \$100,000

The Commission's Order Modifying and Approving Economic Development Plan in Part and Providing For Further Procedures, issued and effective June 2, 2004 in Case Nos. 02-E-0198 and 02-G-0199 (the "June Order"), provided the Guidelines for the Economic Development Reports in Appendix A of the June Order.

Electric

The Company is providing its review of the Economic Development Zone ("EDZ")¹, the Empire Zone Rate ("EZR"), and the Incremental Load Rate ("ILR") incentives, as well as the evaluation of the Non-Rate Assistance Program and Flex Rate Contracts for 2011.

Rate Incentives

RG&E offers two electric rate incentives to businesses who are Empire Zone certified by New York State. The EDZ rate is a grandfathered electricity rate applicable to customers who were Empire Zone certified *prior to January 1, 2005*. For businesses that are Empire Zone certified *after January 1, 2005 up to June 30, 2010*, RG&E offers an EZR, which provides a discount on the delivery portion of the bill. (Note: According to Empire State Development, the Empire Zone Program officially concluded on June 30, 2010.)

The JP Order approved new delivery rates for EZR and ILR. The ILR incentive provides a discount on the delivery portion of the customer's bill. This rate is available to customers who meet certain growth criteria for this program and are classified under certain SIC codes.

Please refer to Attachment A for additional details of RG&E's review for customers enrolled in the EDZ, EZR and ILR rate incentive programs.

Flex Rate Contracts

During 2011 there were no Flex Rate Contracts in effect.

Non-Rate Assistance

Please refer to Attachment B for a progress and activity report of the Non-Rate Assistance distributed during 2011.

In 2011, 39 applications were processed for grant assistance under RG&E's non-rate assistance programs. Approximately \$3.4 million in RG&E assistance will contribute to approximately \$141 million in capital investment by customers and approximately 6,200 kilowatts of expected new electric load. Individual projects are monitored through

¹ On 1/1/05, RG&E revised its rates for customers with Empire Zone certificates that have an eligibility date of 01/01/05 or later and is referred to as the Empire Zone Rate ("EZR"). Customers with Empire Zone certificates prior to 01/01/05 are not affected, as long as their zone certificate remains valid.

RG&E's application process to ensure achievement of program eligibility requirements.

It should be noted that these statistics reflect projects at different stages of completion. Consequently, for a multi-year project, a portion of RG&E assistance may have been either initiated or completed in 2011 and the amounts stated above do not reflect the total amount of assistance. These situations are identified in Attachment B.

In addition to the above benefits, the applicants have reported that these investments will create or retain over 2,875 jobs. It is noted that although job numbers were identified by applicants during the application process, achievement of employment targets is not a requirement for eligibility under RG&E's non-rate assistance programs. Therefore, job verification is not performed by RG&E.

Gas

The Company is providing its evaluation of the Economic Development Zone ("GEZ") and the Empire Zone Rate ("GZR") incentives in this report, as well as the evaluation of the Non-Rate Assistance Program.

Rate Incentives

In accordance with the JP Order, the Company discontinued the availability of the GZR to new customers effective September 26, 2010. Existing GZR customers are permitted to receive incentives for the remaining term of their Empire zone certification. The GEZ rate is a grandfathered gas delivery rate applicable to customers who were Empire Zone certified *prior to January 1, 2005*. .

Non-Rate Assistance

Through December 31, 2011, no gas infrastructure assistance was awarded in the Prime Site Utility Infrastructure or the Brownfield/Building Redevelopment Programs..
