DPS Staff's question was: Do provisions of the Joint Proposal (JP) (including appendices B through F) and exhibits unrelated to the three factual issues set forth in Your Honors' May 8, 2012 Ruling on Issues as being the subject of the upcoming evidentiary hearings need to be sponsored by a witness(es) (presumably by affidavit) before being marked for identification and received into evidence? It is obvious to DPS Staff that provisions of the JP and exhibits that are related to the three factual issues identified in the Ruling will need to be sponsored by a witness(es), so our question relates only to issues unrelated to the three issues specified as being the subject of the evidentiary hearings in this proceeding.
