

Dear Mr. Lichtenstein:

The application, by Entrix Telecom, Inc. on November 21, 2002, for a Certificate of Public Convenience and Necessity to operate in New York State as a reseller of telephone service, without authority to provide local exchange service, is hereby approved. This approval is based upon the accuracy of the information provided in the company's application and may be revoked if the application is found to contain false or misleading information, for failure to file or maintain current tariffs, or for violation of Commission rules and regulations.

The company must file an original tariff within 60 days of the date of this letter and may not provide telephone service to the public until the tariff is approved. Model tariffs and filing instructions are provided on the Commission's website at http://www.dps.state.ny.us/cpcn.htm#tariffs.

The company is <u>not</u> authorized to use its own operators to handle 0- (emergency or non-emergency) calls. Such calls must be routed to another telephone company or operator services provider authorized to handle such calls, until such time as an amended Certificate of Public Convenience and Necessity is obtained pursuant to Part 649.6 of the Commission's rules.

The company must comply with applicable federal laws, New York State Public Service Law and related state statutes, and the Commission's rules and regulations.

The company is also required to file a Statement of Gross Intrastate Operating Revenues by March 31 each year. It will be notified in writing each year of the required content and format of this report.

Finally, please complete and return the enclosed, two-page questionnaire to Maria Le Boeuf of our staff within 30 days of receipt of this letter. This information will be added to the directory of telephone companies posted at our website, in order to help consumers search for companies available to meet their telecommunications needs.
