

SECTION 1. Legislative Intent. It is the intent of this Local Law to establish a Cattaraugus County Motor Vehicle Use Tax.

SECTION 2. Definitions. As used in this Local Law, the following terms shall have the meanings indicated:

2.1 Buses. The same meaning as defined in §104 of the Vehicle and Traffic Law, as amended.

2.2 Passenger motor vehicle. Any motor vehicle subject to the registration fee as provided for in §401(6) of the Vehicle and Traffic Law.

2.3 Truck. The same meaning as defined in §401 of the Vehicle and Traffic Law, as amended.

SECTION 3. Imposition of Tax.

3.1 Pursuant to the Vehicle and Traffic Law and §§1202(a) and 1202(c) of the Tax Law, a special motor vehicle use fee on vehicle registrations is

hereby imposed on motor vehicles registered within Cattaraugus County. Such fee shall be charged in accordance with the following schedule:

- (a) A tax of \$5.00 per annum for the use of passenger motor vehicles of a type commonly used for noncommercial purposes owned by residents of the County for each such vehicle weighing 3,500 pounds or less and a tax of \$10.00 per annum for such vehicles in excess of 3,500 pounds; and
- (b) A tax of \$10.00 per annum for the use of trucks, buses and other such commercial vehicles used principally in connection with a business carried on within the County, except when owned and used in connection with the operation of a farm by the owner or tenant thereof.

3.2 The fee shall be paid for all registrations and renewals of registrations for which the registration fee is established in §401(6)(a) or (7) of the Vehicle and Traffic Law.

- (a) The fee shall be applicable to an original or renewal registration transaction only, and not to a reregistration transaction. If no fee for a registration transaction is due, no county motor vehicle use fee shall be due on that transaction.
- (b) The applicability of such fee shall be determined based upon the information on the application for registration, as well as any additional documentation required by the Commissioner of Motor Vehicles.
- (c) The receipt for payment of such fee may be the registration certificate, whether or not it indicates the amount of the fee paid.

SECTION 4. Exemptions.

4.1 The tax imposed by this Local Law shall not be imposed upon any vehicle exempt from the registration fee pursuant to the Vehicle and Traffic Law.

4.2 The fee imposed by this local law shall not be imposed upon nonprofit religious, charitable or educational organizations qualified for exemption with the New York State Department of Taxation and Finance.

SECTION 5. Administration and Collection of Fee by Commissioner of New York State Department of Motor Vehicles.

5.1 As authorized under Tax Law §1202(c), the motor vehicle use fee shall be administered and collected on behalf of Cattaraugus County by the Commissioner of the New York State Department of Motor Vehicles, or his or her agents.

5.2 Pursuant to Tax Law §1202(c), the New York State Commissioner of Motor Vehicles is authorized, on behalf of Cattaraugus County, to make the payment of such fee a condition precedent to the registration or registration renewal of any vehicle subject to the fee imposed by this local law.

5.3 The Chair of the Cattaraugus County Legislature is hereby authorized and directed to negotiate and enter into an agreement with the Commissioner of the New York State Department of Motor Vehicles for the implementation of this local law, and such agreement shall provide for the exclusive method of collection, custody and remittal of the proceeds of any such fee and for the payment by the County of the reasonable expenses incurred by the New York State Department of Motor Vehicles in connection with the collection and administration of such fee.

5.4 Such agreement shall also provide that the Cattaraugus County Treasurer, upon request, not more frequently than once in each calendar year at a time agreed upon by the State Comptroller, shall audit the accuracy of the payments, distributions and remittances to Cattaraugus County pursuant to this local law.

5.5 The such agreement shall set forth, in detail, policies and procedures for collection for underpayment and for refunds. Such agreement shall also set forth procedures for deposit and retention of funds and indemnification.

SECTION 6. Judicial Review. Any determination made hereunder by the County of Cattaraugus shall be reviewable pursuant to Article 78 of the Civil Practice Law and Rules.

SECTION 7. Recovery of Fee. Whenever any person fails to pay the fee due hereunder, proceedings to recover such fees, as well as any applicable penalties and/or interest, shall be the responsibility of Cattaraugus County, as set forth in the agreement. A final penalty schedule shall be subject to the approval of the Cattaraugus County Legislature.

SECTION 8. Dedication of Funds. All fees collected hereunder and remitted to Cattaraugus County shall be used for the purchase of equipment for the County Department of Public Works.

SECTION 9. Severability. If any provision of this Local Law shall be adjudged by any court of competent jurisdiction to be invalid, then such adjudication, shall not effect, impair or invalidate the remainder thereof, but shall be confined in its operation to the particular provision directly involved in the controversy in which such judgment shall have been rendered.

SECTION 1. Authority.

This law is adopted pursuant to the authority granted the Town in Section 10 of the Municipal Home Rule Law.

SECTION 2. Title.

This local law shall be entitled "Maintenance of Property" in the Town of Humphrey, New York.

SECTION 3. Purpose.

The Town Board hereby declares that a clean wholesome, and attractive environment are of vital importance to the continued general welfare of its citizens, and that regulation of the deposit, accumulation, or maintenance of junk regardless of quantity is hereby prohibited anywhere within sight of persons lawfully traveling the public highways or within sight of neighboring property. By adoption of this law the Town of Humphrey declares its intent to preserve and promote a reasonable quality of environment and aesthetics and to prohibit actions and conduct which tend to depreciate not only the property on which it is located by also the property of other persons in the neighborhood and the community generally.

SECTION 3. Definitions.

The words used in this law shall be defined as follows:

Antique Motor Vehicle: a motor vehicle, but not a reproduction thereof, manufactured more than twenty-five years prior to the current year, which has been maintained in or restored to, or will be maintained in or restored to, a condition which is substantially in conformance with the manufacturer's specifications.

Clutter, Litter, and Debris: ordinary household or commercial trash such as paper, barrels, cartons, boxes, crates, furniture, rungs, clothing, rags, mattresses, blankets, tires, lumber, brick, stone and other building materials no longer intended or in condition for ordinary use; and any and all tangible personal property no longer intended or in condition for ordinary and customary use.

Enforcement Officer: the building code enforcement officer, Town Constable, or any person appointed by the Town Board to enforce the provisions of this law.

Junk: one or more of the following items: junk appliance, junk furniture, junk mobile home, junk vehicle or clutter, litter and debris.

Junk Appliance: any stove, washing machine, dryer, freezer, refrigerator, air conditioner, television or other household device or equipment which is abandoned, junked, discarded or wholly or partially dismantled.

Junk Furniture: abandoned, discarded or irreparably damaged pieces of indoor furniture including, but not limited to, sofas, lounge chairs, mattresses, bed frames, desks, tables, chairs and chests of drawers and like items.

Junk Mobile Home: any enclosed dwelling built upon a chassis, motor vehicle, or trailer used or designed to be used for either permanent or temporary living and/or sleeping purposes including motor homes, truck campers, camping trailers, campers, travel trailers, pop-up trailers, tent trailers and overnight trailers; which meets two out of three of the following conditions for six months or more:

1. the electrical service is disconnected or terminated;
2. it is abandoned as a dwelling unit;
3. it is no longer habitable for residential occupancy;
4. excludes travel trailers and recreational vehicles registered in current year with the Department of Motor Vehicles.

Junk Vehicle: any motor vehicle, or used parts or waste materials from motor vehicles which, taken together, equal in bulk one or more such vehicle, which meets all of the following conditions:

1. it is unregistered; and
2. it is either abandoned, wrecked, stored, discarded, dismantled, or partly dismantled; and
3. it is not in condition for legal use upon the public highway.

With respect to any motor vehicle not required to be licensed or motor vehicle not usually used on public highways, the fact that such motor vehicle is not in condition to be removed under its own power shall be presumptive evidence that such motor vehicle is a junk vehicle unless refuted by verifiable and credible proof.

Motor Vehicle: all vehicles propelled or drawn by power other than muscular power originally intended for use on public highways, including but not limited to automobile, bus, trailer, truck, tractor, motor home, motorcycle and mini-bicycle. This term shall also include all terrain vehicle or snowmobile.

Person: any individual, firm, partnership, association, corporation, company or organization of any kind.

SECTION 4. Prohibited Acts.

The deposit, accumulation, or storage of junk, regardless of quantity, is hereby prohibited anywhere within sight of persons lawfully traveling the public highways or within sight of neighboring property. The provisions of this law shall also be applicable to conditions existing at the time of enactment of this local law.

SECTION 5. Exclusions.

The following conditions are hereby excluded from the definition of junk vehicle:

1. unlicensed vehicles in operating condition stored by or for the owner while the owner is (a) a full time student of the immediate family attending a school, college or university; (b) a member of the United State Armed Forces; (c) suffering from an injury or illness requiring hospitalization or confinement to a bed.
2. Seasonal vehicles or machinery during their off-season if kept in a location not visible from any road, street or highway.
3. Farm machinery, including tractors, where such machinery is actively used. Farm machinery kept for part shall be kept in a location not visible from any road, street or highway.
4. An antique motor vehicle which is being restored.

SECTION 6. Complaints.

Any person may file a complaint with the enforcement officer that a violation of this law may have taken place or is allegedly taking place. All complaints shall be in writing and shall specify the property on which the alleged violation has occurred. The enforcement officer may also investigate any alleged violation that he or she has reason to believe has occurred or is occurring.

SECTION 7. Notice to Comply.

Following an investigation of the property, the enforcement officer shall file a written report of the violations observed with the Town Clerk. The enforcement officer shall prepare a written Notice to Comply which shall contain the following:

1. the name of the owner or occupant to whom the notice shall be addressed.
2. the location of the premises involved in the violation.

3. a statement of the facts which it is alleged violates this law.
4. a demand that the junk be removed or placed so as to be in compliance with this law within fourteen days of the service or mailing of the notice.
5. a statement that a failure to comply with the demand may result in prosecution.
6. a copy of this law.

The Notice to Comply shall be service by personal service or by certified mail, return receipt requested, addressed to the last known address of the property owner or occupant. If said certified mail is refused or returned, service upon the property owner or occupant shall be made by mailing a copy of the notice by first class mail to the address of the property owner in a post office or official depository under the exclusive care and custody of the United States Postal Service within the State of New York. Service shall be deemed complete upon depositing the notice in an official depository of the United State Postal Service within the State of New York.

SECTION 8. Extension.

Upon the application of the owner or occupant showing reasonable cause, the Town Board may grant an extension of up to thirty days for the owner or occupant to comply with the demands of the Notice to Comply.

SECTION 9. Enforcement.

If after the expiration of fourteen days from the date of mailing the notice provided in Section 10 above, or after the completion of any extension period allowed in Section 11 above, the owner or occupant shall fail to comply with the requirements of this law, the enforcement officer or Town Board may institute enforcement procedures as follows:

1. the enforcement office is hereby authorized pursuant to Criminal Procedure Law Section 150.20 (3) to issue an appearance ticket to any person whom the enforcement officer has reason to believe has violated this law, and shall cause such person to appear before the Town Justice.
2. the Town reserves the right to seek a court order to have the junk removed and disposed of. The expense thereof shall be charged to the property so affected by including such expense in the next annual tax levy against the property.

SECTION 10. Penalties.

SECTION 1. Legislative Intent. It is the intent of this Local Law to establish a Cattaraugus County Motor Vehicle Use Tax.

SECTION 2. Definitions. As used in this Local Law, the following terms shall have the meanings indicated:

2.1 *Buses.* The same meaning as defined in §104 of the Vehicle and Traffic Law, as amended.

2.2 *Passenger motor vehicle.* Any motor vehicle subject to the registration fee as provided for in §401(6) of the Vehicle and Traffic Law.

2.3 *Truck.* The same meaning as defined in §401 of the Vehicle and Traffic Law, as amended.

SECTION 3. Imposition of Tax.

3.1 Pursuant to the Vehicle and Traffic Law and §§1202(a) and 1202(c) of the Tax Law, a special motor vehicle use fee on vehicle registrations is

hereby imposed on motor vehicles registered within Cattaraugus County. Such fee shall be charged in accordance with the following schedule:

- (a) A tax of \$5.00 per annum for the use of passenger motor vehicles of a type commonly used for noncommercial purposes owned by residents of the County for each such vehicle weighing 3,500 pounds or less and a tax of \$10.00 per annum for such vehicles in excess of 3,500 pounds; and
- (b) A tax of \$10.00 per annum for the use of trucks, buses and other such commercial vehicles used principally in connection with a business carried on within the County, except when owned and used in connection with the operation of a farm by the owner or tenant thereof.

3.2 The fee shall be paid for all registrations and renewals of registrations for which the registration fee is established in §401(6)(a) or (7) of the Vehicle and Traffic Law.

- (a) The fee shall be applicable to an original or renewal registration transaction only, and not to a reregistration transaction. If no fee for a registration transaction is due, no county motor vehicle use fee shall be due on that transaction.
- (b) The applicability of such fee shall be determined based upon the information on the application for registration, as well as any additional documentation required by the Commissioner of Motor Vehicles.
- (c) The receipt for payment of such fee may be the registration certificate, whether or not it indicates the amount of the fee paid.

SECTION 4. Exemptions.

4.1 The tax imposed by this Local Law shall not be imposed upon any vehicle exempt from the registration fee pursuant to the Vehicle and Traffic Law.

4.2 The fee imposed by this local law shall not be imposed upon nonprofit religious, charitable or educational organizations qualified for exemption with the New York State Department of Taxation and Finance.

SECTION 5. Administration and Collection of Fee by Commissioner of New York State Department of Motor Vehicles.

5.1 As authorized under Tax Law §1202(c), the motor vehicle use fee shall be administered and collected on behalf of Cattaraugus County by the Commissioner of the New York State Department of Motor Vehicles, or his or her agents.

5.2 Pursuant to Tax Law §1202(c), the New York State Commissioner of Motor Vehicles is authorized, on behalf of Cattaraugus County, to make the payment of such fee a condition precedent to the registration or registration renewal of any vehicle subject to the fee imposed by this local law.

5.3 The Chair of the Cattaraugus County Legislature is hereby authorized and directed to negotiate and enter into an agreement with the Commissioner of the New York State Department of Motor Vehicles for the implementation of this local law, and such agreement shall provide for the exclusive method of collection, custody and remittal of the proceeds of any such fee and for the payment by the County of the reasonable expenses incurred by the New York State Department of Motor Vehicles in connection with the collection and administration of such fee.

5.4 Such agreement shall also provide that the Cattaraugus County Treasurer, upon request, not more frequently than once in each calendar year at a time agreed upon by the State Comptroller, shall audit the accuracy of the payments, distributions and remittances to Cattaraugus County pursuant to this local law.

5.5 The such agreement shall set forth, in detail, policies and procedures for collection for underpayment and for refunds. Such agreement shall also set forth procedures for deposit and retention of funds and indemnification.

SECTION 6. Judicial Review. Any determination made hereunder by the County of Cattaraugus shall be reviewable pursuant to Article 78 of the Civil Practice Law and Rules.

SECTION 7. Recovery of Fee. Whenever any person fails to pay the fee due hereunder, proceedings to recover such fees, as well as any applicable penalties and/or interest, shall be the responsibility of Cattaraugus County, as set forth in the agreement. A final penalty schedule shall be subject to the approval of the Cattaraugus County Legislature.

SECTION 8. Dedication of Funds. All fees collected hereunder and remitted to Cattaraugus County shall be used for the purchase of equipment for the County Department of Public Works.
