The Temporary Operating Authority and/or Franchise under which your company has been providing service is expiring. The Commission has adopted a new policy which grants Temporary Operating Authority for an indefinite term subject to certain conditions, compliance with which will be actively monitored by Commission Staff.

The Company and the municipality are in a franchise renewal process. The Public Service Commission has determined that it is in the public interest to grant Temporary Operating Authority so that the Company may continue to provide cable television services during the negotiation of the franchise renewal and consumers and municipalities will continue to be afforded protections under the laws, regulation and the franchise. The expired franchise sets forth certain rights and obligations of the parties. Part 895 of our cable rules, 16 NYCRR, sets forth franchise standards which must be contained in a cable television franchise presented to the Commission for approval.

This Temporary Operating Authority is granted on condition that the parties shall continue to comply, unreservedly with all the terms and provisions of their expired franchise and all of the provisions set forth in Part 895 of our cable rules. In the event any franchise provision is inconsistent with a provision of Part 895, the provision most beneficial to the subscriber shall be controlling. Furthermore, this Temporary Operating Authority is granted with the express understanding that the parties are, and will remain in active negotiation toward a renewal agreement.

The Municipal Assistance Section will actively monitor compliance with the conditions of the Commission's Temporary Operating Authority. Please be advised that the Department provides consulting and mediation services that could assist the municipality and the company with their negotiations.
