## 1 Introduction

This quarterly report reflects progress on Energy Efficiency Portfolio Standard (EEPS II) Program evaluation activities administered by the New York State Energy Research and Development Authority (NYSERDA). This report contains summaries of recently-completed evaluations and the status of evaluation recommendations through March 31, 2014. Information contained within this report comports with the guidance received from the New York State Department of Public Service (DPS) and discussed by the Evaluation Advisory Group in July 2012 and the E2 Working Group in March 2014.
