This application is submitted by Cablevision Systems Westchester Corporation ("Cablevision"), 1111 Stewart Avenue, Bethpage, New York 11714, (516) 803-2300, for a renewal of the Certificate of Confirmation for the cable television franchise in the Town of Bedford, New York ("Town").

The Town granted a cable television franchise to Cablevision by agreement dated January 9, 2002, which was scheduled to expire on September 16, 2013.

Attached hereto and designated as Exhibit I, please find a copy of Cablevision's Application for Renewal of the Cable Television Franchise of the Town of Bedford.

On June 19, 2012, after publication of notice, a copy of which is annexed hereto and designated as Exhibit II, public hearings were held on Cablevision's application. A full discussion of Cablevision's proposals and qualifications and the generating of the proposed franchise renewal were held.

On June 19, 2012, the Town Board passed a Resolution granting a nonexclusive franchise to Cablevision, a copy of which is annexed hereto as Exhibit III. On June 20, 2012, the Town executed a nonexclusive cable television franchise agreement with Cablevision within the geographical boundaries of the Town, a copy of which agreement is annexed hereto as Exhibit IV.
